Position Summary:

The UWNCO Development Director is responsible for fundraising and development activities of the organization including annual campaign planning and coordination, solicitation of leadership gifts, and management of donor relationships. In concert with the Executive Director, the Development Director is responsible for increasing the number of donors and size of donations to United Way of North Central Ohio.

Essential Functions:

- Maintain industry-leading knowledge of fundraising processes and best practices
- Administer and track donor solicitations, outreach and follow-up timelines
- Monitor all donor information, provide statistical analysis to Executive Director
- Effectively and consistently manage relationships with workplace campaign coordinators
- Support and manage affinity and coalition groups as they develop
- Coordinate essential acknowledgement, recognition and appreciation programs for campaign volunteers, leadership givers, corporate partners, affinity groups and other donors
- Oversee large fundraising events, community awareness events and events targeting volunteers
- Handle confidential donor information
- Perform other duties as assigned

Marketing:

- Work with Communications Director to ensure that assigned county communications to the public are professional, accurate and consistent with the mission and meet UWW standards
- Plan and implement the recruitment of community/funded partner volunteers
- Use public speaking in order to educate key audiences about important community issues and United Way's work to enhance the outcomes of their investment
- Develop and grow all special events, including Day of Action, Designer Bag Bingo, annual awards, and others as needed
- Collaborate with the Executive Director to set strategy and tone for fundraising, emphasizing innovative and creative ideas
